A permit constitutes permission to maintain, store, use or handle materials, or to conduct processes which produce conditions hazardous to life or property, or to install equipment used in connection with such activities. Such permission shall not be construed as authority to violate, cancel or set aside any of the provisions of the code. Such permit shall not take the place of any license required by law. **Fees:** Fees will be accessed when your permit is issued.

CONDITIONS FOR APPROVAL:

1. Provide two (2) additional exits as shown on drawing. Each exit to provided a minimum clear width Of 6-feet.
2. Provide exit signage and directional marking to all required exits.
3. Provide emergency lighting throughout structure.
4. Provide a 2A:10B:C portable fire extinguishers throughout structure.
5. Exit doors must swing in the direction of egress.
6. Provide signage that indicates smoking is prohibited in or around a structure.
7. No combustible waste may be stored on the floor or within 30 feet of the structure.

REVOCAION OF PERMITS:

The Park City Fire Service District is authorized to suspend or revoke a permit when:

1. The permit has been used by a person other than the person to whom the permit was issued.
2. The permit has been used for a location other than that for which it was issued.
3. Any of the conditions or limitations set forth in the permit have been violated.
4. The applicant failed, refused or neglected to comply with orders or notices duly served in accordance with the provisions of this code within the time provided therein.
5. There has been a false statement or misrepresentation as to a material fact in the application or plans on which the permit or application was based.
6. The permit was issued in error or in violation of an ordinance, regulation or the code.
