- C. Chief Gee reported that the Fire District will be purchasing a power gurney. Chief Gee explained that this will minimize the risk for injury in certain situations.
- D. AC Zanetti reported on a recent cardiac arrest save; the patient came by recently to have a picture taken with the crew that responded on that call. Chief Zanetti reported on a second cardiac arrest save last week with a marathon participant.

- E. Captain Evans reported on some recent trench rescue training. A big thank you goes out to Questar, who willingly came out and dug the trenches for the training, free of charge.
- **VII. Adjournment:** With no further business to come before the board, Commissioner Cashel called for a motion to adjourn, moved by Commissioner Bacon, seconded by Commissioner Walker. Meeting adjourned at 7:00 p.m.
