IV. Old Business

A. Possible approval of Policies III-A-700 Accepting Gifts and Loans, III-H-200 Statutory Benefits, III-H-600 Retirement Benefits

He explained that he meets with the Chair and Vice-Chair once a month. Mr. Howard called him about something else, and he talked to him in passing about that item during the conversation. Chair Simpson explained that meeting with the Chair and Vice-Chair is new and is something she requested. She explained that there may be instances where she may have to recuse herself, and she wanted to be sure that she, the Vice Chair, and Chief Hewitt have good ongoing communication in the event she has to step out of an issue.
